# B. Ordinance No. 2023-04 - 2023 Tax Levy Ordinance

# C. Resolution No. 2023-03 - Approving Articles of Agreement for the South West Special Recreation Association (SWSRA)

The resolution along with the SWSRA Articles of Agreement (revised) which reflects an increase in the member contribution rate from .02 to .0225 was presented. This rate has never been increased in the history of SWSRA and has been long overdue as SWSRA has struggled over the years in maintaining a balanced budget. The decision to raise the rate with it being reviewed annually was a unanimous decision by the SWSRA Board of Directors.

The manual primarily serves as an orientation to the Park District upon election or appointment to the Board. The information contained in the manual summarizes the Park District operations, along with highlighting key policies and procedures. Each new or elected member of the Board will receive a manual and will be distributed information to include in the manual from time to time.
