# A. Review of Minutes and Financial Reports

The December disbursements totaling \$123,665.77; the income statement through December 2023; P-card expenses of \$9,335.18; and payroll of \$53,954.96 were reviewed by the Park Commissioners.

Recommended Action: That the Board of Park Commissioners approves the Minutes and Financial Reports as presented as part of the Administrative Matters/Consent Agenda during the Regular Board Meeting.

#### B. Revision to Personnel Practices Manual - Section 4.03: Personal Time

Recommended changes to the Personal Time policy were discussed. The existing policy on personal time, the suggested revisions, and a new version of the policy were reviewed. The revisions are being proposed due to the new Paid Leave Act which went into effect on January 1, now requiring all employers to provide this benefit to all employees (full and part-time). Up to mid-December, park districts and school districts were exempt from the Act. But the Cook County used their home rule authority to make the change to now include park and school districts. The policy was reviewed by corporate counsel and is now in line with the required Act.

Because it was such a late ruling by the county board, we were given an exception to have the policy in place by February 1.

# Recommended Action: That the Board of Park Commissioners approves the revisions to Section 4.03 of the Personnel Practices Manual to reflect the requirements of the Paid Leave Act, passed by law effective January 1, 2024.

#### C. <u>Revision to Personnel Practices Manual - Section 4.02: Vacation Leave (Parttime)</u>

The Park District has made a concerted effort to award part-time staff, as they are highly relied upon for programs and services. This was the reason for instituting the Vacation Leave for part-time employees' policy a few years ago.

With the new Paid Leave Act, there is no longer the need to continue this benefit for part-time employees. The provisions under the Leave Act will result in more time for part-time employees versus what is offered presently.

# **Recommended Action: That the Board of Park Commissioners eliminate Section 4.02 - Vacation Leave for Part-time employees.**

D. Local Government Efficiency Report
